- A. BUDGET AND FISCAL REPORTS Not available
- B. WATER/SEWER: Dave Horn
 - a. Thanks to Sig for all he is doing with the water operation
 - b. The leak on Shasta Drive had a broken shutoff valve. It has been capped off
 - c. Replaced the North valve and it can now be used. 13823 Ridge Lane still has no water. Dave & Sig will dig out valves on that property and have Roto-Rooter repair
 - d. Dave Horn is catching up on filing the delinquent reports
 - e. Craig Bunas with SWRCB will be out on October 1st for our 3-year inspection
 - f. Pace Analytical will be filing the Consumer Confidence Report

- b. Willow Lane Larry & Sig cleaned up stumps We will be adding a drain/culvert in high drainage areas

D. ADMINISTRATIVE:

 Deposits from 2020 to the present have been verified against QuickBooks and bank check scans to ensure accounts are as accurate as possible. Statements will begin going out shortly

NEW BUSINESS:

A. Bullock's Law

a. Cindy located the document, and we had our legal counsel review it. Per our counsel, the next step is to see if the subdivision map from December 5, 1965, has been repealed or modified in any way. This is not a District document, and the

District doesn't have any authority to enforce it. It would have to be enforced by the property owners by creating a homeowner's association or by code enforcement

- B. Helipad
 - a. Sheila is going to research the requirements. We believe we need a 100 ft area, lit, level, clear for landing
- C. Update on speedbumps, speed limit signs, handicapped signs, AED machine
 - a. Suggestion is to start with speed limit signs or slow down signs throughout town and see if that helps slow people down (\$45.99 x4). If not, then move to speed bumps (\$599.96 x4 or \$899.94 x6)
 - b. Talk to Brandon Chriss to see if CHP can ticket violators
 - c. Handicapped sign donated by Sheila and Danny Thank you!!
 - d. AED Market Refurbished AED machine (\$525 \$1500 Extra pads/extended warranty available)
- D. Resolution 2024-25-1 for TCSD Water/Sewer Collections Policy attached
 - a. Deferred to next month
